

YCVSC Eagles Soccer Club Parental Participation Form

I/we the parent(s)/guardian(s) of a child/children applying to participate in the North Carolina Youth Soccer Association (NCYSA) as a member of the YMCA of Catawba Valley Soccer Club (YCSVC) do hereby agree to abide by the following terms and conditions of participation:

- The YCVSC Eagles Soccer Club Team Parental Participation Form must be signed by the parent(s)/guardian(s) of the applying player(s) and filed with the Head Registrar of my home association, or the applying player's NCYSA player card will be withheld and the player(s) will not be allowed to participate on any YCVSC Eagles Soccer Club team.
- The completed YCVSC Eagles Soccer Club Team Parental Participation Form for each new team must be filed with the YCVSC Eagles Soccer Club Discipline & Appeals Liaison before the first day of play of the season the team is first registered to play in order to avoid NCYSA player cards from being withheld.
- I understand and acknowledge that as a parent of a participant in NCYSA, I am representing my home association and the YCVSC Eagles Soccer Club at all times and as an ambassador of these programs, my conduct both verbally and physically reflect upon these organizations.
- I will respect the opposing team, its players, parents and coaches and I will not engage in **any** disrespectful conduct.
- I will respect all referees. I will not address, make comments or gestures to, or attempt to gain the attention of a referee in any manner. I understand the Coach and Assistant Coaches of my team are the only parties authorized by the YCVSC Eagles Soccer Club to interact with or question a referee.
- I will respect my team Coach, Assistant Coaches and Team Manager and will abide by his/her/their decisions, directions and leadership. I understand and agree that my coaching staff is responsible for maintaining the conduct of the team and their sideline (including parents and guests) and the coaching staff is authorized by the YCVSC Eagles Soccer Club to eject me or my guests from any practice or any match without warning.
- If my coaching staff orders me to leave sight and sound of a soccer match (the soccer complex) or a referee orders me to leave sight and sound of a soccer match (ejection), I will respect his/her decision and will leave the soccer complex immediately without hesitation and without any further verbal or physical misconduct
- I understand that it is mandatory for a YCVSC Eagles Soccer Club team official to report violations of these rules to the YCVSC Eagles Soccer Club Discipline and Appeals Chairperson. Violations will be recorded by YCVSC Eagles Soccer Club as "family violations" of the YCVSC Eagles Soccer Club player. Violations will be accumulated as a family, not as individual parents, and will not be limited to the team on which they occurred. (Example: If Mom is ejected in one game, and Dad is ejected in another game, Dad's ejection becomes the family's second ejection. If the family has multiple children playing in different age divisions under the YCVSC Eagles Soccer Club, their violations will be accumulated against all teams they participate on.).

If I violate any of the above provisions, I will adhere to the following discipline:

- Violation of any of the above provisions regardless of whether an ejection occurs or not – 2 game suspension in addition to the remainder of the current game.
- Ejection from a game by a referee or match official First Offense = 1st Family Violation - Both parents/guardians will serve a 2 game suspension in addition to the remainder of the current match. My son/daughter will be allowed to complete the current match, but will serve a one game suspension with us. (The child cannot play in the first match in which both parents are suspended but the child can play in the second match in which both parents are suspended.)
- Ejection from a game by a referee or match official Second Offense by Same Person, or First Offense by Second Parent/Guardian) = 2nd Family Violation - Both parents/guardians and all of their children will be suspended from participating with the YCVSC Eagles Soccer Club for the remainder of the soccer year. (Year defined as 8/1 until 7/31). Parents/Guardians and players must meet with the Executive Board of YCVSC Eagles Soccer Club in order to apply to return to YCVSC Eagles Soccer Club the following year.
- Failure to immediately leave the soccer complex of a match after ejection by an YCVSC Eagles Soccer Club authorized official, or continued verbal or physical disrespectful conduct after ejection - Both parents/guardians and all of their children will be suspended from participating with the YCVSC Eagles Soccer Club for the remainder of the soccer year. (Year defined as 8/1 until 7/31). Parents/Guardians and players must meet with the Executive Board of YCVSC Eagles Soccer Club to apply to return to YCVSC Eagles Soccer Club the following year.
- Verbal assault/hostile challenge or physical assault of a player, parent, coach or referee - Upon receiving notice of a conviction by a NCYSA Discipline & Appeals hearing - Both parents/guardians and their child/children will receive a lifetime suspension from participating in the YCVSC Eagles Soccer Club.
